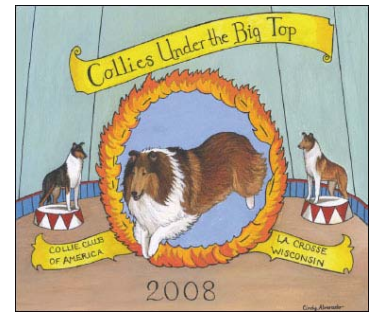


Judging Schedule

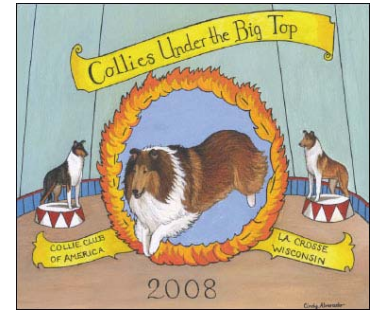

Welcome to Collie Club of America National Specialty Agility Trial! We hope everyone has a great time.

Please review your enclosed entry information. If there are any errors or problems, email the trial secretary at rdotrialsec@sbcglobal.net (preferred) or phone (630) 790-8426. Except for the first class of the day in each ring, all start times are approximate. Dogs in the "B" classes will run first, followed by dogs in the "A" classes for each jump height. Dogs in the Preferred program will run after dogs in the "A" classes in their corresponding jump height except in the FAST classes when running jump heights from small to tall.

WORKERS

Since this is a small trial, we'll need all the help we can get. If you didn't send in a worker form with your entry, and would like to volunteer, please send me a note at rdotrialsec@sbcglobal.net.

ARMBANDS

If you submitted a height card, your armband will be in your check-in packet. If you did not submit a height card, you will need to come to the scoretable to show your height card and receive your armbands. If you did not submit a card with your entry you may mail a copy or e-mail a scan of it to me at rdotrialsec@sbcglobal.net.

If you do not have a height card, your dog will need to be measured before you are allowed to run (because our judge is a Volunteer Measuring Official, all dogs, including those jumping 24" or 26", that do not have a height card will need to be measured).

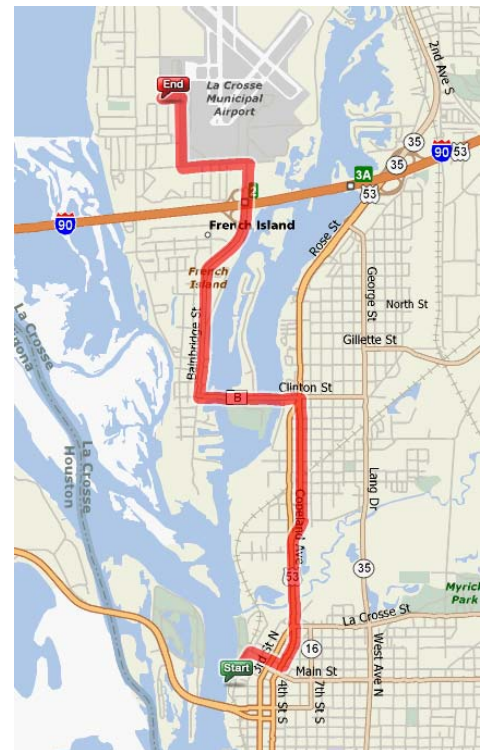

DIRECTIONS:

From I-90: Follow the signs to the airport, get off at Exit 2 and head the airport terminal. As you are approaching the terminal, watch for signs pointing left to the Airport Industrial Park. Turn left and then you will curve to the right and we are the third building on the right, you can't miss us.

From the La Crosse Center:

Head North on Front St. S toward State St. Turn Right on State St. Turn Left on 4th St. North / US-53 N. Turn Left onto Clinton St. Turn Right onto Bainbridge St. Turn Left onto Fanta Reed Rd W. Turn Right onto Airport Rd. Turn left and then you will curve to the right and we are the third building on the right, you can't miss us.
