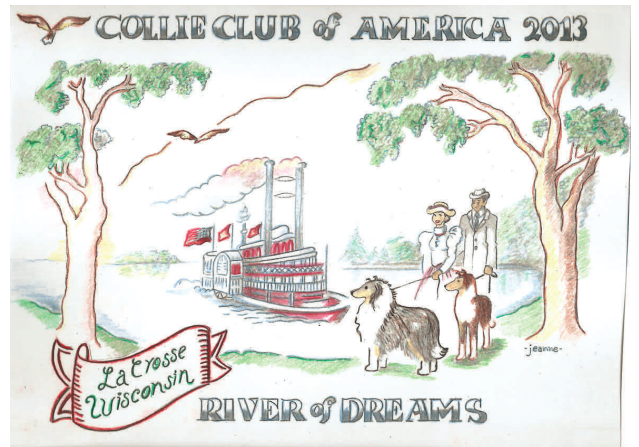

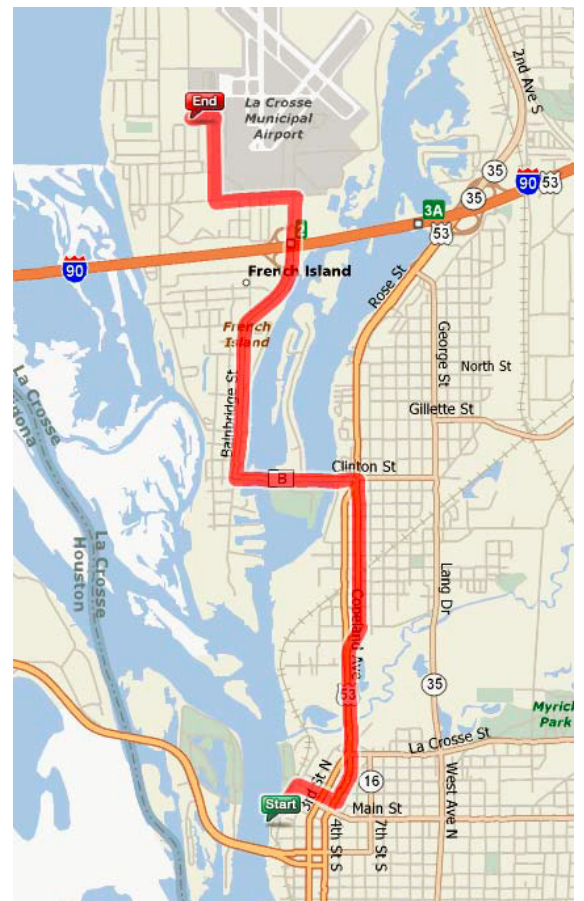

DIRECTIONS:

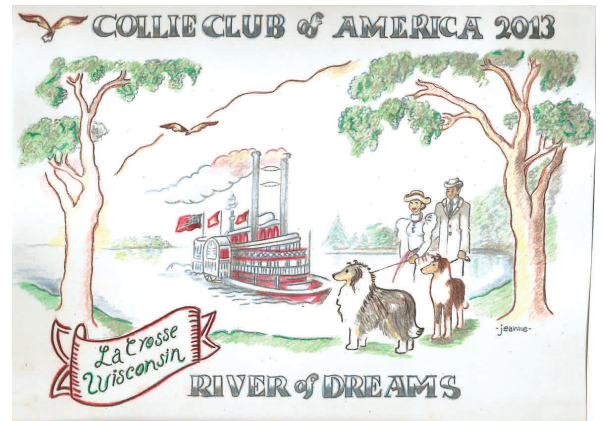
From I-90: Follow the signs to the airport, get off at Exit 2 and head for the airport terminal. As you are approaching the terminal, watch for signs pointing left to the Airport Industrial Park. Turn left and then you will curve to the right and we are the third building on the right, you can't miss us.

From the La Crosse Center:

Head North on Front St. S toward State St. Turn Right on State St. Turn Left on 4th St. North / US-53 N. Turn Left onto Clinton St. Turn Right onto Bainbridge St. Turn Left onto Fanta Reed Rd W.
