DIRECTIONS TO THE TRIAL LOCATION:

From Tulsa: Take US-412 to the Cimarron Tpke. Go 43.8 mi on US-412 (Cimarron Tpke West) to the US-177/Stillwater/Ponca City exit.

Exit right then turn left (north) onto US-177.

Go 20.6 mi to US-60 (do not take US-60 Business) and turn right (east).

Go 3.1 mi to Hunt Rd. and turn right (south).

Go 2.5 mi and turn left (north) onto Wilde Rd. go approx. 1/3 mi to trial site.

From Oklahoma City: Take I-35 North approx. 86 mi to the US-60/Tonkawa/Ponca City exit 214.

Exit right (east) onto US-60 (do not take US-60 business) and go approx. 18.6 mi to Hunt Rd and turn right (south).

Go 2.5 mi and turn left (north) onto Wilde Rd. go approx. 1/3 mi to trial site.

From Wichita Kansas / Oklahoma State Line: Take I-35 South approx. 20.9 mi to the US-60/Tonkawa/Ponca City exit 214.

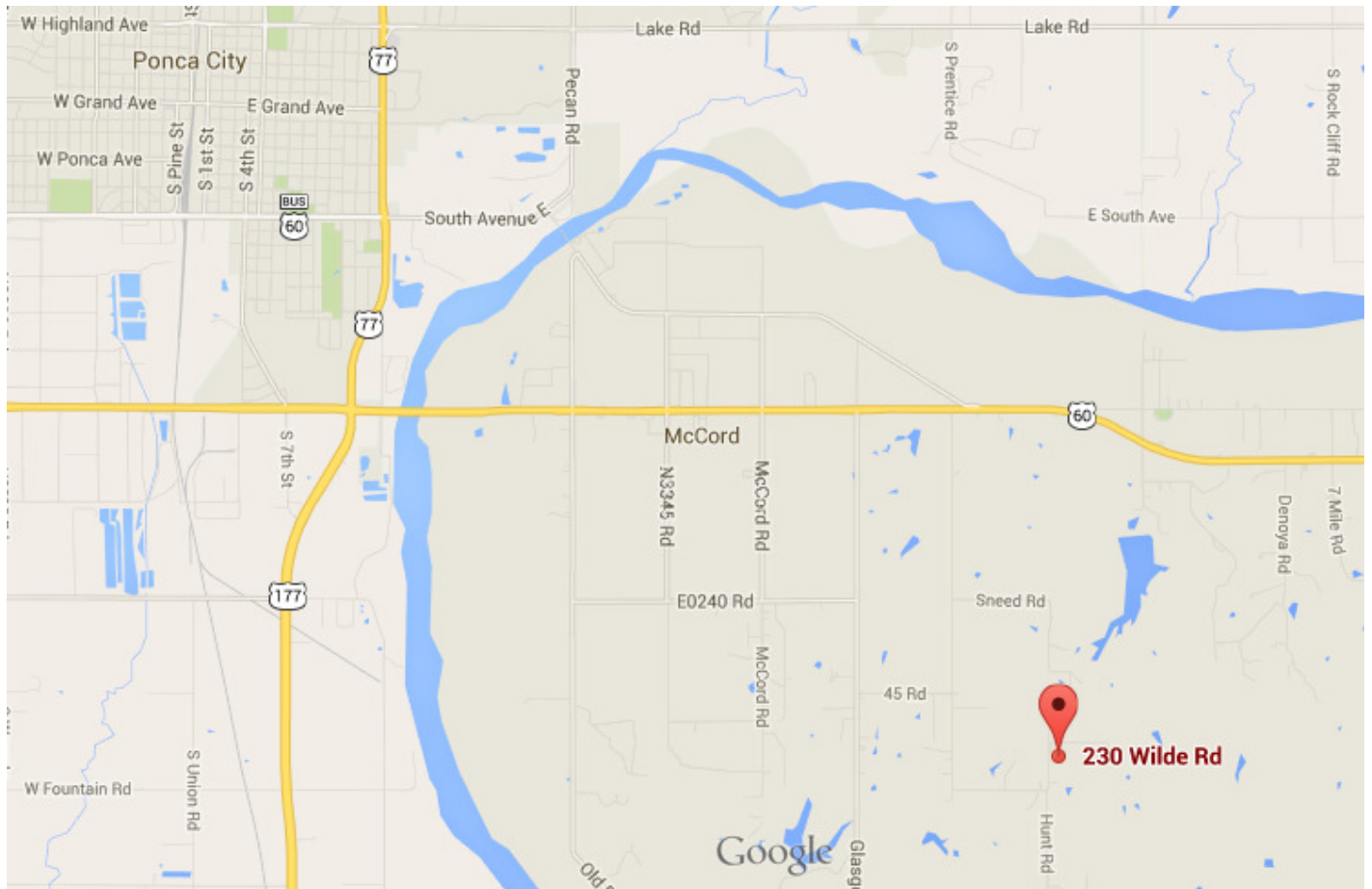
Exit left (east) onto US-60 (do not take US-60 business) and go approx. 18.6 mi to Hunt Rd and turn right (south).

Go 2.5 mi and turn left (north) onto Wilde Rd. go approx. 1/3 mi to trial site.

From US-75 at Bartlesville, OK: Turn west on US-60 (SE Adams Blvd).

Go 3.7 mi and turn right (north) onto US-60 (SR-123) then left (west) onto US-60 (Bartlesville Rd) and stay on US-60 62.8 mi to Hunt Rd and turn left (south).

Go 2.5 mi and turn left (north) onto Wilde Rd. go approx. 1/3 mi to trial site.
