#### **Arrival times:**

Check in will start at 7:30am. Please do not come into the building before that. HD Teams All Levels and Novice and Advanced teams will run first with Excellent and Masters running after the completion of respective Novice and Advanced elements. Detective will run all of trial 1, then move onto trial 2.

#### **Check In Process:**

Check in will be just inside the main entrance to the school. Please leave your dogs in the car while you check in.

## **General Briefing:**

Handler's briefing at 8:00 AM. Briefing will be done inside the school past the check in area. The scheduled start time for judging is 8:30 AM. Please do not arrive before 7:30 AM. There will be no walkthroughs of the search areas. The judges will brief at the start line.

#### **HD Handlers:**

You must present your article to the steward in a plastic bag. You are responsible for bringing the plastic bag and article. We will not be providing the articles or bags as only your scent should be on the items.

#### **Ribbons & Results:**

We will have placement ribbons and qualifying ribbons in a designated area. No ribbons will be mailed. No dogs in the ribbon area please!

#### Move ups:

Will only be made from Saturday to Sunday. Move ups for Sunday must be submitted by the end of Saturday trials. The trial concludes when the ribbons are awarded for the last class held for the day. No move ups will be taken Saturday evening or Sunday morning. #### **Parking and Crating:**

All crating will be done in vehicles. There is a parking lot in front of the school that you can use. Please be mindful of cones that may block out parking due to line of sight for detective and exterior searches.

#### **Pottying Yourself:**

Bathrooms are located in the main hallway of the school. On the left side of the hallway past buried.

#### **Pottying Your Dog:**

Potty area is on the east side of the school across the driveway. Do not allow your dog to potty on direct school grounds, meaning the grassy areas that the school is on. We will have five gallon buckets placed around the trial site with poop bags for you to use. Please be courteous and clean up after your dog! If you are caught not cleaning up after your dog, you will be asked to leave the trial without a refund. Map of the area at the bottom of this letter.

#### **On Site Behavior:**

Absolutely NO flexible or retractable leashes permitted outside of search areas. Dogs must remain on leash at all times. Any handlers who do not follow these rules will be asked to leave the trial with no refund. Please refer to our premium regarding leashes at trial sites.
