JUDGING PROGRAM

Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having their dog ready at ringside at the scheduled time. The Club will not be responsible for and is not obligated for providing service through a public service system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

TRANSFER OF ENTRIES

Handlers who wish to transfer their dogs to a higher-level class in any event must notify the Show Secretary at least 30 minutes prior to the start of that event's judging for the day.

SITE INFORMATION

IMPORTANT: TO ALL EXHIBITORS - PLEASE READ CAREFULLY!

The building will NOT OPEN UNTIL 6:30 AM

DO NOT COME ANY EARLIER THAN 6:30 AM.

We know that some of your dogs are very exuberant and can't help but bark. For those that are not able to prevent your dogs from barking, please park in between the buildings so our neighbors in homes to the west are not disturbed.

Do not walk your dogs along the fence on the west side of the drainage area. Walk dogs on the east side of the drainage area and along the south side of the buildings.

Please do not park in the parking spots directly in front of the gymnastics club next to us.

If anyone is found breaking these rules they will be asked to leave without any refund.

EXHIBITORS ARE RESPONSIBLE FOR CLEANING UP AFTER THEMSELVES & THEIR DOGS!

Friday night setup will be available from 4:30 – 7:00 p.m.

Practice runs for both obedience and conformation, including ramp practice, will be available for \$5/run AFTER the rings are set up until 7:00 p.m.
