The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Each judge will take a 45 minute lunch at his/her discretion.

Ample indoor crating is available in designated areas only. There is no space for unentered dogs.

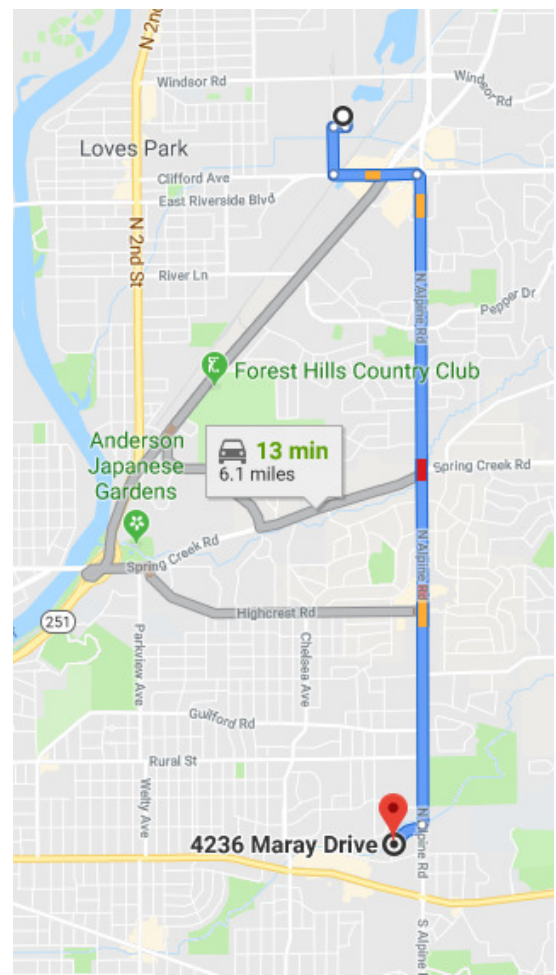
No food is available at the trial site; there are many restaurants nearby.

Take slight right at Maray Dr. Clinic is on the right.



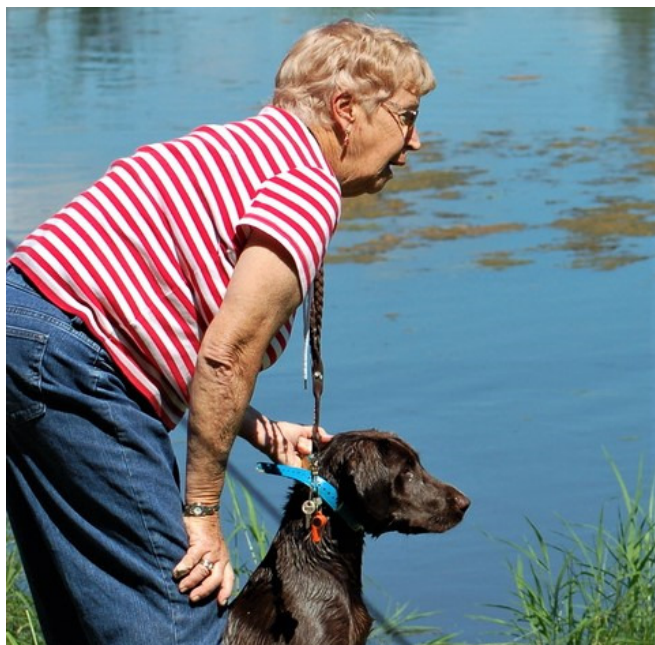
Forest City Dog Training Club
