Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Each judge will take a 45 minute lunch at his/her discretion.

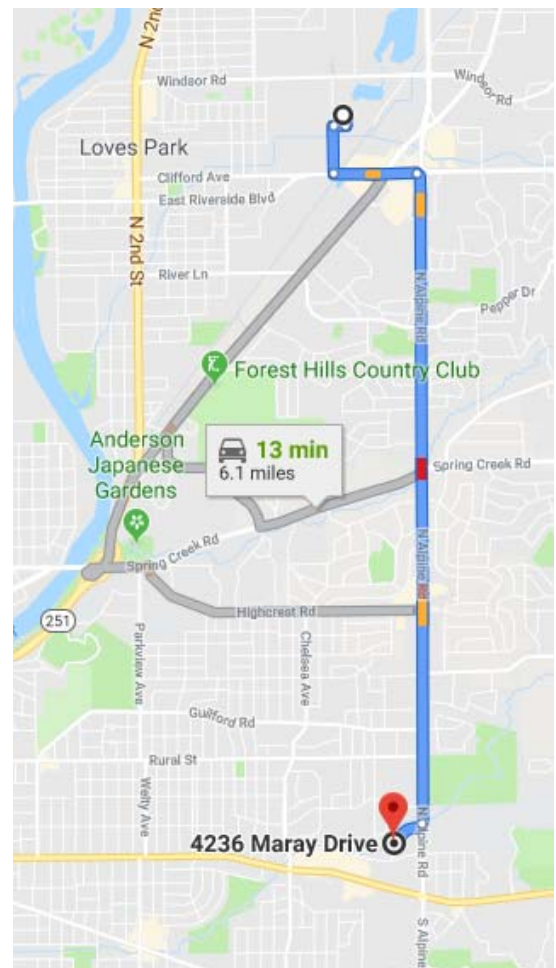

## Forest City Dog Training Club CoVID-19 Policy (revised)

Masks must be worn 100% of the time while in the building. NO EXCEPTIONS.

NO ONE other than the person showing a dog will be allowed in the building. No guests or spectators.

Judging times will be noted in the program. We will not start before the listed time. Please do not arrive more than 60 minutes before your class. When your class is over, please leave the building. If you want to socialize, please do so outside.

We will have a central area to check in to your classes for that day. You will get your armbands at that time. We will check you in at the rings. Please leave a minimum of 6' between you and the gate stewards.

**Crating** will be allowed on the agility side of our building. We will rely on you to practice social distancing while setting up your crate(s) and chair. Rows will be marked to ensure a 6' aisle. There will be **NO CRATING OR CHAIRS** allowed on the ring side of the building. **Depending on the number of entries, crates may have to be brought in daily.**

You will be allowed to watch at the rings but only in designated areas. **STANDING ROOM only with social distancing. No dogs in the spectator area.**

We will have 2 rings with indicated warm up areas. The "next" dog will be allowed in the warm up area.. Please do not warm up on the crating side due to social distancing.

All surfaces will be wiped down after each entry. Stewards will wear gloves and change after each entry. All equipment will be handled by gloved stewards.

Only you will touch your leash and/ or dumbbell.

Inanimate objects will be used as figure 8 posts.

We will have a separate entrance and exit within the building.

We will also have a separate entrance and exit at each ring.

Please do not touch anyone else's dog or equipment.

We ask everyone to follow the guidelines set by the Federal, State and AKC committees to allow us to be safe while enjoying our sport.
