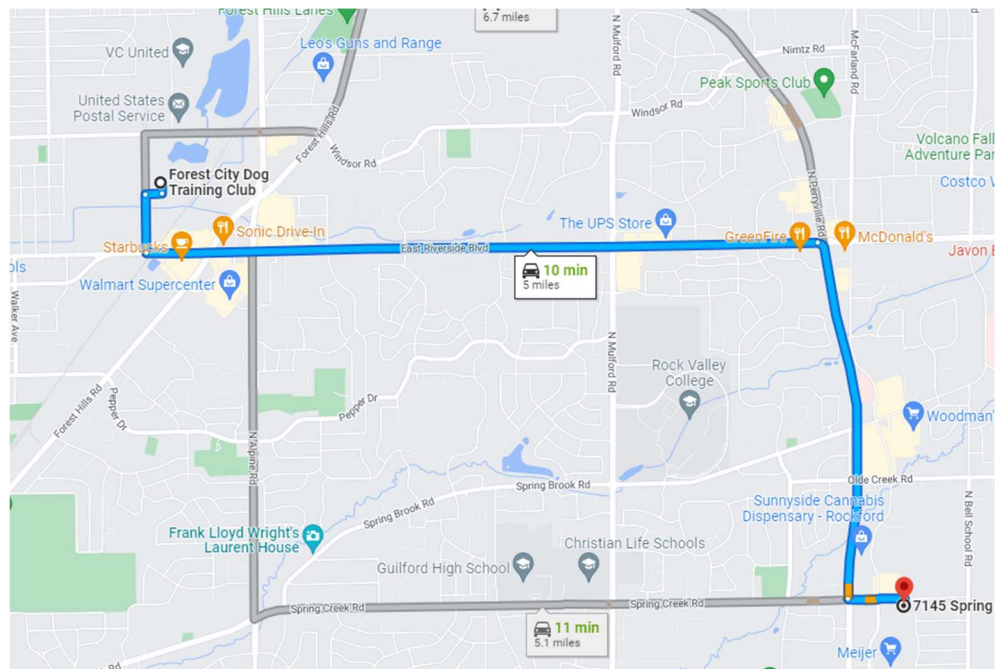
Each judge will take a 45 minute lunch at his/her discretion.

Clinic is on the right.



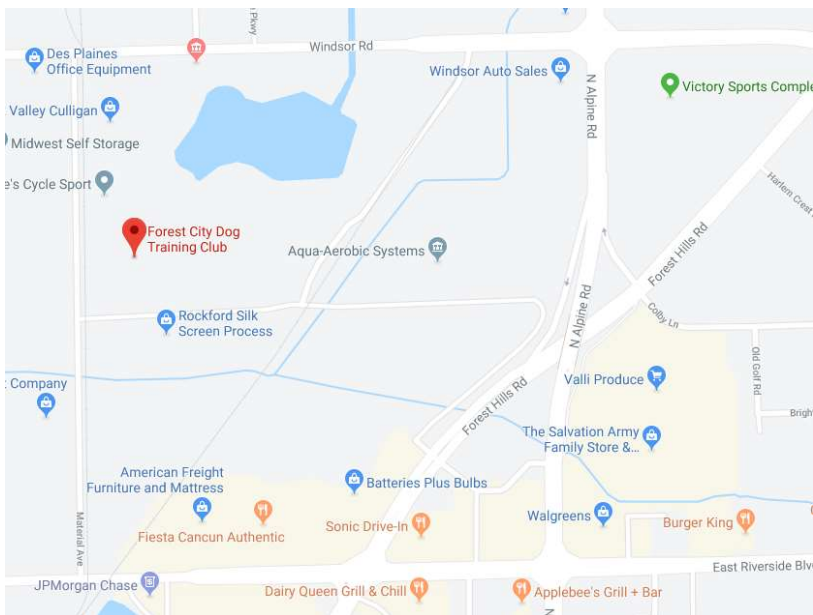
