ROUTES TO SHOW

The WAG building is located in Spring Grove, IL on Route 12, just west of
the intersection of Route 12 and Spring Grove / Winn Roads.

From the North: Take Route 12 South (East Rt 12) to Spring Grove. WAG is
one block before Spring Grove Road and will be on the right side of the road.

From the South: Take Route 12 North (West Rt 12) to Spring Grove. WAG is
one block after Spring Grove / Winn Roads and will be on the left side of the
road.

From the East: Take Rt 173 West to Winn Road South to Rt 12 West. WAG
is one block west of Winn Road.

From the West: Take Rt 172 East to Route 12 South to Spring Grove. WAG
is one block before Spring Grove / Winn Roads.
