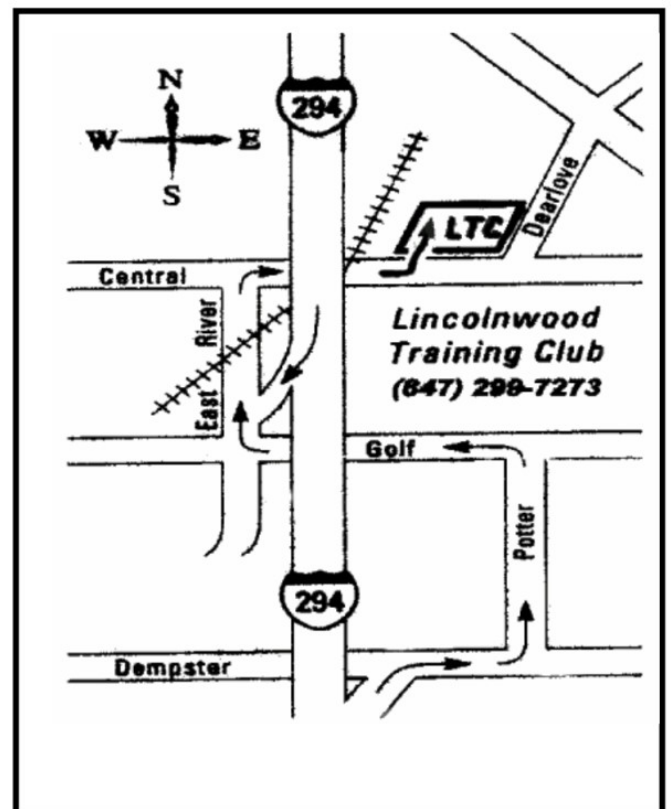
The building will be open at 8:00 a.m. Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

The judge will take a lunch at his discretion.

## DIRECTIONS TO TRIAL SITE

**From the south:** Exit I-294 at Dempster Eastbound. Take Dempster to Potter and turn left. Follow Potter to Golf Rd. and turn left. Follow Golf to East River Road (you will go back under I-294). Follow River to Central and turn right. The club will be on your left when you come back under I-294.

**From the north:** exit I-294 at E River Rd exit 45. Head North on River Rd, and turn right on Central. The club will be on your left when you come back under I-294.
