Crating space and exercise areas will be designated; please use the appropriate areas for each.

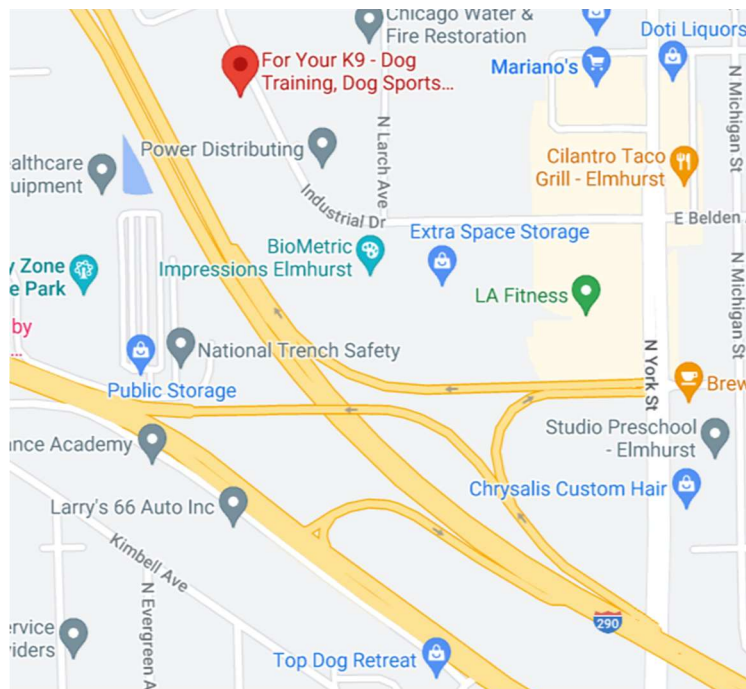
