Thank you for entering Stone City Kennel Club's obedience trials. These events are being held at the Stone City Kennel Club building, 13606 W. Laraway Road, New Lenox, IL 60451.

Running order will be tall to small each day.

Please check the included entry information for your dog(s). If you find any errors notify the trial secretary via email at secretary@livetrial.net or phone at (630) 790-8426.

The building will be open at 7:00 a.m. Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

CHECK-IN INSTRUCTIONS:

There will be a line of tables outside the building with all check in materials. There will be a check in table for each ring at the corresponding door.

MASKS ARE REQUIRED AT TIME OF CHECK IN AND ENTRY INTO BUILDING.

1. At initial check please approach end for Temperature check. Your temp will be recorded on our waiver and handed to you to fill out.
2. Hand in filled out waiver to receive your colored entry wrist band. You must have your wrist band on to enter the building.
3. Check in for your trial.
4. Pick up your Goody bag, number, and if applicable your course maps
5. There will be a large copy of your armband number(s). Please display this in the window of your vehicle facing the aisle of the parking lot.

Please note Will County has tightened restrictions. As we are running at low capacity for a normal trial, we do ask you to please social distance and avoid clustering. Hand sanitizer is available inside and at check in tables. If you have any questions, please see the Show Chair.

Please remember lunch will not be provided so prepare accordingly.

Each judge will take a lunch at his/her discretion.

PLEASE NOTE: No indoor crating is allowed for this trial.

DIRECTIONS TO TRIAL SITE: Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

FROM I-80 (eastbound) take Rt. 30 exit south. Go 1.5 miles and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road.

FROM I 80 (westbound) take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.

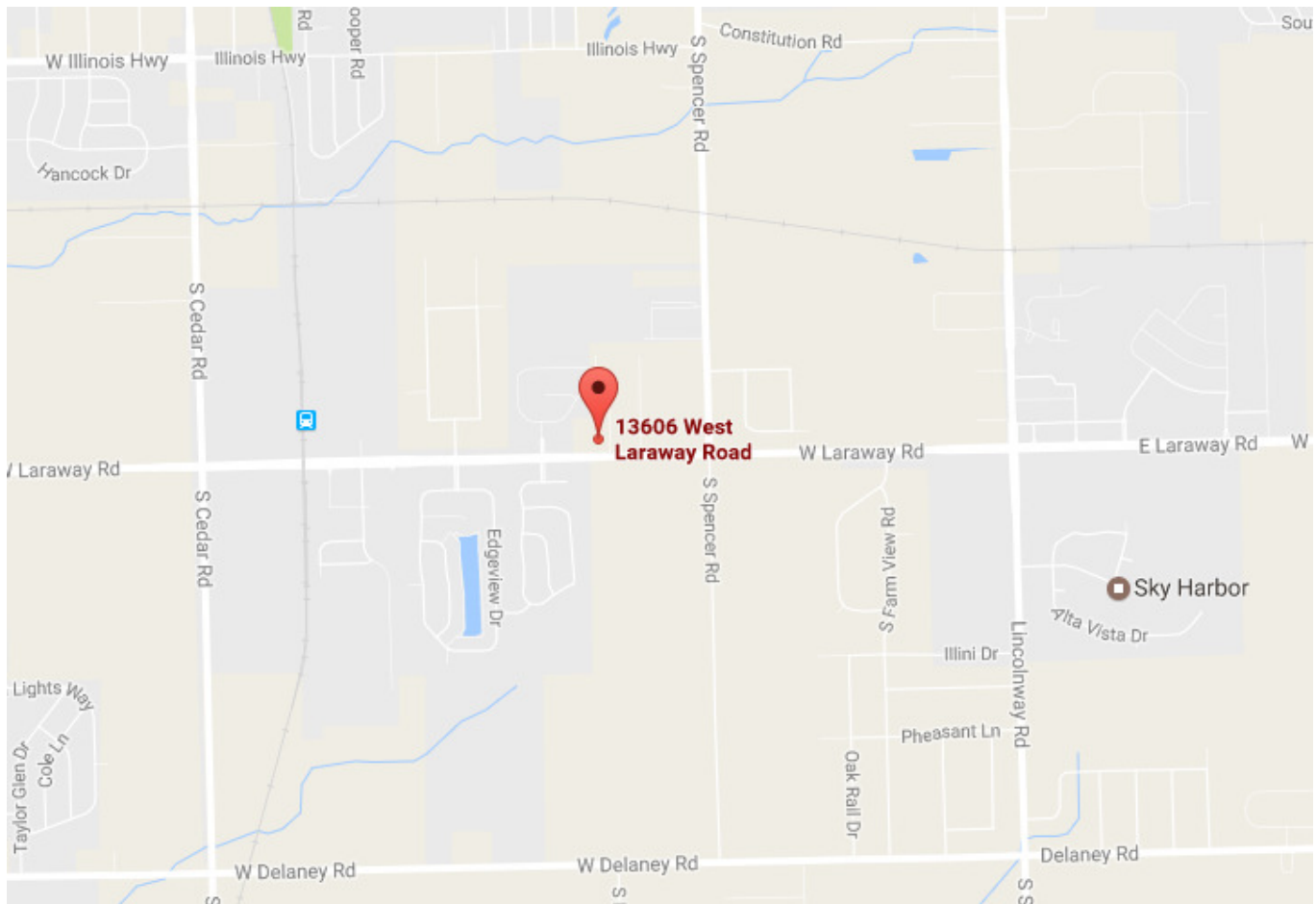
