The building will be open at 7:00 a.m.

Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Each judge will take a lunch at his/her discretion.

Indoor crating is available. Crate mats are required to be placed under dog crates in the building.

A light lunch will be served to all exhibitors.

The building will be available for setup and drop-in training from 10:00 am - 2:00 pm on Monday, December 30th.

Crating space and exercise areas will be designated; please use the appropriate areas for each.

DIRECTIONS TO THE SITE:

From I-80: Exit Route 30 (Maple Street) East. To Cedar Road stop light turn Left. To Francis Road turn Right. The 4H field will be on your left.

From I-355: Exit on Route 6. Go East on Route 6, to Cedar stoplight turn Right. To Francis Road turn Left. The 4H field will be on your left.

From Route 50 or 45: Go to Laraway Road or Route 30. Turn West to Schoolhouse Road, turn Right. (just West of Wolf Road - Stop Sign if coming off of Laraway, Stop Light if coming off of Route 30); Deadend on Francis Road - turn Left. The 4H field will be on your right about a mile down.
