**PLEASE NOTE: Due to the current COVID-19 restrictions in Will County only 5 exhibitors will be allowed in the building at a time.** Try to arrive no earlier than 30 minutes before your scheduled ring time.

**EXPRESS CHECK-IN:** We will have express check-in at the front door. You will need to drop off your COVID-19 release and pick up an envelope with your armbands and rubber band.

Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Crating space and exercise areas will be designated; please use the appropriate areas for each.

- Crating will be allowed in the building but be sure your chair is 6' away from the people around you
- Social distancing must be maintained at all times
- Face coverings will be required

**From I-80:** Exit Route 30 (Maple Street) East. To Cedar Road stop light turn Left. To Francis Road turn Right. The 4H field will be on your left.

**From I-355:** Exit on Route 6. Go East on Route 6, to Cedar stoplight turn Right. To Francis Road turn Left. The 4H field will be on your left.

**From Route 50 or 45:** Go to Laraway Road or Route 30. Turn West to Schoolhouse Road, turn Right. (just West of Wolf Road - Stop Sign if coming off of Laraway, Stop Light if coming off of Route 30); Deadend on Francis Road - turn Left. The 4H field will be on your right about a mile down.
