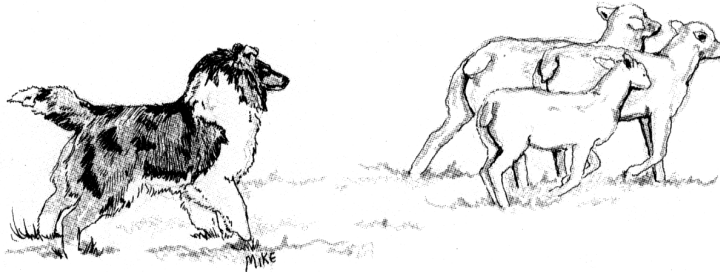

Magic's Legacy Trial Grounds, W1192 Hwy. B
Genoa City, WI
South of Lake Geneva at the WI / IL border.

Open to **Collies Only**, Rough and Smooth

DIRECTIONS

Genoa City, WI is located 9 miles south of Lake Geneva at the WI / IL border.

From the North: Take US Hwy 12 south until Freeway ends; at the stop sign turn right (west) onto Hwy H. Follow Hwy H to the first stop sign, which will be in downtown Genoa City, and turn left onto Hwy B, then keep on Hwy B by turning right at the next stop sign. Continue 1½ miles to farm, which is on your right. Site is on your right; park by small house.

From the South: Take US Hwy 12 north until you cross the WI / IL state line. About ¼ mile further Hwy 12 splits off to the right to begin the freeway; Hwy H bears to the left, which will take you into Genoa City. Continue as above.

Livestock used will be dog-broke sheep (St. Croix/cross) in groups of three. (\$150.00 value/per head) Livestock seriously injured while being worked must be paid for by the participant whose dog is working stock at that time

THINGS TO REMEMBER

Chair	<i>Buckle collar</i> when working
Old shoes	Crate/Exercise pen
Dress for weather	Water
	Leash

Dogs should not be near pen until shortly before their turn, so they don't get themselves or the sheep too excited. Please use exercise area and pick up after your dog. Porto potty provided for the rest of us.

OTHER RULES TO FOLLOW

1. All dogs must be 6 months of age or older.
2. All dogs must be current on their vaccinations (or titer) and parasite free.
3. All dogs must be leashed (**NOT FLEXI PLEASE**) or crated except when working.
4. Livestock seriously injured, while being worked, must be paid for by the participant working stock at that time.
5. Bitches in season may participate in the clinic, but will run last

What will I do?

Your dog will be put on a 6-foot soft rope and go in the pen with the Tester. Shannon will help introduce your dog to the sheep and help him/her do its best. Your dog may want you in there also, and then Shannon will help you work your dog. You will have a blast and a day to remember.

Entry Agreement and Indemnity

The person who signs this Entry represents that she/he is authorized to enter into this Agreement and Indemnity on behalf of both the Handler and Owner of the entered dog in consideration of acceptance of this entry.

Handler and Owner whether or not members of Collie Club of America agrees to abide by the rules and regulations of the Collie Club of America and all other rules and/or regulations shown in the premium list for this event.

Handler and Owner certify that the entered dog is not a hazard to persons, dogs or property. In the event the entered dog injures any livestock, the owner will pay for veterinarian services. If the injury is severe, the owner will pay the market value or value stated in the premium list of the stock injured.

Handler and Owner acknowledge that herding events are inherently dangerous and have risks of injury to persons. Handler and Owner agree to assume the risk of any harm arising from the hazards associated with the herding event which include but are not limited to, parking areas, ground conditions, animals, stock used in the herding event, and other dogs.

Handler and Owner hereby release the Collie Club of America and Collie Club of Southern WI , their officers, directors agents and members, including Shannon Wolfe, Magic's Legacy (its officers, agents and directors) and the owners of the site of the event, from any and all liability for any injury, loss or damage, of whatever kind or nature, whether to person or property which occurs directly or indirectly or associated with the herding event.

Handler and Owner agrees to indemnify and hold harmless the Collie Club of America and Collie Club of Southern WI , their officers, directors agents and members, including Shannon Wolfe, Magic's Legacy (its officers, agents and directors) and the owners of the site of the event, from any and all claims, loss or expense, including attorney's fees, arising out of any injury, loss or damage, of whatever kind or nature, whether to person or property which occurs directly or indirectly or associated with acts or failure to act of Handler or Owner, or any of the dogs entered in the herding event or brought to the site of the herding event.
