**JUDGING:** Please note that judging of B course duck classes will run concurrently with judging for the A course sheep classes. This schedule should minimize ring conflicts; judges may move dogs in the run order to accommodate conflicts if necessary.

On Friday, A sheep will take priority over B ducks.

Per AKC rules, judges have the authority to refuse to judge any dog which does not appear within five minutes of being called for its run.

### From the South:



190 to Rt. 47 Exit South to Burlington Road. Follow the roundabout to Burlington Road West (first exit). Agility at the Farm is the red building is on the right side of the road 0.5 miles down.

### From the West:

190 to Rt. 20 Exit South. 20 will split into 47/20, take the 47 fork. Continue South to Burlington Road. Follow the roundabout to Burlington Road West (first exit). Agility at the Farm is the red building is on the right side of the road 0.5 miles down.
