




**Coming from Tulsa:** Keep straight onto OK-51 East/Broken Arrow Expressway 5.4 mi. Take ramp right and follow signs for Kenosha St. 0.3 mi. Turn left onto E 71st St S/E Kenosha St, 5.6 mi. Turn right onto S 273rd East Ave, 0.6 mi. Turn left onto E 77th St/E 77th S, 0.2 mi.

**Coming from Muskogee:** Keep straight onto US-69/N 32nd St, 5.3 mi. Take ramp left for Muskogee Tpke West, 23.7 mi. Take ramp right for Creek Tpke toward Creek Tpke E, 1.4 mi. At exit 25, take ramp right and follow signs for Kenosha St, 0.3 mi. Turn left onto E 71st St S/E Kenosha St, 3.6 mi. Turn right onto S 273rd East Ave, 0.6 mi. Turn left onto E 77th St/E 77th, 0.2 mi.

**Coming from Oklahoma City:** Take I-44 East (toll road) Take Creek Turnpike East exit, EXIT 218, toward Jenks/Broken Arrow Take the Kenosha St. exit, EXIT 25 Turn left onto E 71st St S/E Kenosha St. Turn right onto S 273rd East Ave Turn left onto E 77th St/E 77th St S.
