


Directions

Genoa City is located 9 miles south of Lake Geneva, WI at the WI/IL border.

From the North: Take US Hwy 12 south until Freeway ends. At stop sign turn right (west) on Hwy. H. Follow H to the first stop sign which will be downtown Genoa City. Turn left one short block and turn right onto Hwy. B (west). Continue 1 1/2 miles to farm on your right. Exhibitor parking by small house.

From the South: Take Hwy 12 north until you cross the WI/IL state line. Hwy 12 will split off to the right to begin the freeway. Hwy H bears to the left which will take you into Genoa City. Continue as above.
