SITE INFORMATION: This show will be held at the **Stone City Kennel Club Building**,
13606 W. Laraway Road, New Lenox, IL 60451
Lunches will be available for purchase onsite. There are fast food restaurants nearby.

Directions to the site are as follows:

Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

FROM I-80 (eastbound) take Rt. 30 exit south. Go 1.5 miles and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road.

FROM I 80 (westbound) take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.
