**SETUP AND BUILDING HOURS:** Setup will be available on Friday, February 21, from 6:00 p.m. through 8:00 p.m. The building will open at 6:30 a.m. on Saturday, February 22. No smoking in show building.

**JUDGING PROGRAM:** Judges are not required to wait for dogs. They will adhere as closely as possible to the judging schedule printed in this program. The owner or handler of each dog is solely responsible for having their dog ready at ringside at the scheduled time. The Club will not be responsible for and is not obligated to call or locate dogs that are not brought into the ring when required. Break for lunch to be determined by the judge.

**TRANSFER OF ENTRIES:** Entrants wishing to transfer from Regular conformation classes to Best of Breed or Junior Show entrants wishing to move to Open or Master must submit their requests in writing to the Secretary no later than 30 minutes prior to the start of judging for the day.

**HEALTH CLINIC:** MDR1 testing swab kits will be offered throughout the day for the dog owner to submit directly to Washington State University. Results will be emailed directly to the owner. Cost of the test is \$60 per dog prepaid online to VCPL.
