**TRANSFER OF ENTRIES:** Entrants wishing to transfer from Regular conformation classes to Best of Breed or Junior Show entrants wishing to move to Open or Master must submit their requests in writing to the Secretary no later than 30 minutes prior to the start of judging for the day.

**HEALTH CLINIC:** MDR1 testing swab kits will be offered throughout the day for the dog owner to submit directly to Washington State University. Results will be emailed directly to the owner. Cost of the test is \$60 per dog prepaid online to VCPL. Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

**FROM I-80 (eastbound)** take Rt. 30 exit south. Go 1.5 miles and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road.

**FROM I 80 (westbound)** take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.
