AKC Agility Trial
April 28 – 29, 2012



Thank you for entering Agility Ability's agility trial. This trial is being held at Pawsitively Heaven Pet Resort, 10051 Kitty Avenue, Chicago Ridge, IL, 60415. Food will not be available on site, but there are plenty of fast food options nearby. Crating is allowed inside the building, but no flexi-leads. Parking is limited in the building's lot, so it will be used for loading and unloading. The staff at Pawsitively Heaven will be outside most of the day to help exhibitors unload and watch over equipment while cars are moved. The following areas may be used for parking. No RVs or motor homes allowed.

- The small parking lot adjacent to the propane company across the street on Virginia (by the giant propane hotdog)
- The lot of the Chicago Ridge Fire Department and Municipal lot across from the building on Anderson
- The street of Kitty Avenue

Pawsitively Heaven **does not** have permission to use the large paved lot across from their facility on Virginia. **IF YOU PARK HERE, YOUR VEHICLE MAY BE TOWED!**

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions.

No Friday setup. Building opens at 6:00 a.m. both Saturday and Sunday. Crating space is limited so please be considerate of other exhibitors.

Please review your enclosed entry information. If there are any errors or problems, please email the trial secretary at rdotrialsec@sbcglobal.net (preferred) or phone (630) 790-8426. Except for the first class of the day in each ring, all start times are approximate. Dogs in the "B" classes will run first, followed by dogs in the "A" classes for each jump height. Dogs in the Preferred program will run after dogs in the "A" classes in their corresponding jump height. Walk throughs will be split at the discretion of the judges.

If you did not request measurement on your entry form, your armband will be available for pickup, along with course maps for the day. If you did request measurement, you will need to have your dog measured by the Volunteer Measuring Official (VMO) who will be at the trial, and then come to the score table to pick up your armband. If you run and are not measured the AKC will remove any legs you may have earned this weekend. If you have received a valid temporary or permanent height card since sending in your entry (i.e. your confirmation still shows "measure"), please let me know so I may mark the database properly and have your armband available in the self-check-in area.

Directions to the site are as follows:

From the north: Take I-294 South to 95th Street (also Rts 12/20) and exit east. Stay to the right and take the ramp to Harlem Road south (second ramp, first will put you back onto I-294 north). At the first light turn left onto 98th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.

From the south: Take I-294 North to 95th Street (also Rts. 12/20) and exit east. Stay in the right lane and take the ramp to Harlem Road south. At the first light turn left onto 98th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.
