Thank you for entering the Great Lakes Belgian Tervuren Club agility trial. This trial is being held at Pawsitively Heaven Pet Resort, 10051 Kitty Avenue, Chicago Ridge, IL, 60415. Food for exhibitors will not be available for purchase on site, but there are plenty of fast food options nearby. Crating is allowed inside the building, but no flexi-leads.

## PARKING:

PARKING is NOT available in the grassy lot across from Pawsitively Heaven. Parking is permitted in the paved lot by Lexington Nursing Home. Parking is also permitted at the Chicago Ridge Municipal Parking lot and the Fire Department parking lot (PLEASE do not block doors).

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their $\operatorname{dog}(\mathrm{s})$ will be asked to leave without a refund. Remember that hotels are considered by the AKC to be part of the trial site, so exhibitors observed not picking up or causing disturbances at the hotels may face AKC sanctions.

No Friday setup. Building opens at 7:00 a.m. both Saturday and Sunday. Crating space is limited so please be considerate of other exhibitors.

Please review your enclosed entry information. If there are any errors or problems, email the trial secretary at secretary@livetrial.net (preferred) or phone (815) 242-5483. Except for the first class of the day in each ring, all start times are approximate. Dogs in the "B" / Master classes will run first, followed by dogs in the "A" / Excellent classes for each jump height. Dogs in the Preferred program will run after dogs in the "A" / Excellent classes in their corresponding jump height. Walk-throughs will be split as described on the judging schedule.

We are not scheduled for a Volunteer Measuring Official at this trial.

## Directions to the site are as follows: 10051 Kitty Ave., Chicago Ridge, IL 60415

From the north: Take I-294 South to 95th Street (also Rts 12/20) and exit east. Stay to the right and take the ramp to Harlem Road south (second ramp, first will put you back onto I-294 north). At the first light turn left onto 99th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.

From the south: Take I-294 North to 95th Street (also Rts. 12/20) and exit east. Stay in the right lane and take the ramp to Harlem Road south. At the first light turn left onto 99th Street. Go to the stop sign and turn right onto Sayre Avenue. Turn left at the next stop sign onto Virginia Avenue. Turn right at the next stop sign and continue on Virginia Avenue. Pawsitively Heaven will be on the left side of the street, just past the fire station.

For the T2B class we will walk 24 " \& $20^{\prime \prime}$, then walk $16^{\prime \prime}, 12$ ", 8 ", 4 " then run all.
All other classes walk together then run.
