Thank you for entering the Havanese Club of America National Specialty agility trial. This trial is being held in the ballroom at the Westin Lombard Yorktown Center, 70 Yorktown Shopping Center, Lombard, IL 60148.

Food will not be provided; there will be a hospitality room in the morning and food may be purchased at the hotel.

RVs may be parked for the day in the general parking lot. Overnight parking must be reserved in advance; please see the national show premium available at http://www.foytrentdogshows.com/ for details.

Crating is allowed inside the building, but no flexi-leads.

PLEASE PICK UP AFTER YOUR DOGS! Potty areas will be clearly marked. Anyone caught not picking up after their dog(s) will be asked to leave without a refund.

Ballroom opens at 6:00 a.m.

Setup for the trial is at 5pm on Monday night, August 10, 2015. You can set up your crating at that time; please join us in helping to set up the trial.

Please review your enclosed entry information. If there are any errors or problems, please email the trial secretary at secretary@livetrial.net (preferred) or phone (630) 790-8426. Dogs in the Master or B classes will run first, followed by dogs in the Excellent or A classes for each jump height. Dogs in the Preferred program will run after dogs in the Excellent or A classes in their corresponding jump height.

If you did not request measurement on your entry form, your armband will be available for pickup, along with course maps for the day. If you did request measurement, you will need to have your dog measured by judge Lisa Potts, who is an AKC Volunteer Measuring Official, and then come to the score table to pick up your armband. If you run and are not measured the AKC will remove any legs you may have earned at the trial. If you have received a valid temporary or permanent height card since sending in your entry (i.e. your confirmation still shows "measure"), please let me know so I may mark the database properly and have your armband available in the self-check-in area.

Directions to the site are as follows:

North: Travel south on Route 53 until it becomes 290 East, then merge on Interstate 355. Continue south on the left towards Joliet and take Butterfield Road (Route 56). Travel toward Aurora and turn left onto Butterfield Road (Route 56), then take a left into Yorktown Shopping Center. Follow the center around to the hotel entrance. West: Travel onto Interstate 88 east and exit onto Highland Avenue. Turn left onto Highland Avenue after the tollbooth, merging to the far right. Then merge right onto Route 56 east and then take a left into the Yorktown Shopping Center. Follow the center around to the hotel parking lot.

East: From 290(Eisenhower Expressway) stay in left 2 lanes and continue onto Interstate 88 west. Continue to the tollbooth and exit on Highland Avenue. Taking Chiropratic College, turn right onto Highland Avenue and merge onto Route 56 (Butterfield). Turn into the Yorktown Shopping Center and the route within the parking lot to the hotel.

South: Travel North onto Route 83 then turn left onto 22nd Street. Take 22nd Street until it turns into Butterfield Road. Turn right into Yorktown Shopping Center and follow center around to the hotel entrance.
