Thank you for entering Stone City Kennel Club's obedience trials. These events are being held at the Stone City Kennel Club building, 13606 W. Laraway Road, New Lenox, IL 60451.

Running order will be tall to small each day.

Please check the included entry information for your dog(s). If you find any errors notify the trial secretary via email at secretary@livetrial.net or phone at (815) 242-5483.

The building will be open at 7:00 a.m. Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Please remember lunch will not be provided so prepare accordingly.

Each judge will take a lunch at his/her discretion.

COVID RULES:

While masks are not required, due to the high community levels of COVID-19 we recommend that all participants wear a mask while indoors. You may remove the mask while in the ring.

DIRECTIONS TO TRIAL SITE: Stone City Kennel Club is located approximately 4 miles west of Rt. 45, or 1 mile east of Cedar Road on Laraway Road in New Lenox.

FROM I-80 (eastbound) take Rt. 30 exit south. Go 1.5 miles and turn right onto Cedar Road. Go 2 miles and at 4-way stop sign turn left (east) onto Laraway and go 1 mile. Clubhouse is located on the North side of the road.

FROM I 80 (westbound) take Rt 45 exit south. Go 5.6 miles and turn right onto Laraway Road and go approximately 4 miles west. Clubhouse will be on your right.
