Thank you for entering South Side All Breed Dog Training Club's rally trials. These events are being held at the Francis Field Youth Building, 801 E. Francis Road, New Lenox, IL 60451.

PLEASE NOTE: Try to arrive no earlier than 30 minutes before your scheduled ring time. Due to the COVID-19 rules we need to keep the number of people on site as small as possible.

EXPRESS CHECK-IN: We will have express check-in at the front door. You will need to drop off your COVID-19 release and pick up an envelope with your rally courses, armbands and rubber band.

The building will be open at 7:00 a.m.

Judges are not required to wait for dogs, and they will adhere as closely as possible to the judging schedule. It is the exhibitor's responsibility to have your dog ready at ringside when it is to be judged, or to notify the judge as soon as possible if you will have a conflict with another ring. The trial-giving club is under no obligation to provide any service for the purpose of calling or locating dogs that are not brought to the ring when required.

Indoor crating is available.

We will have Rally drop in training Monday evening November 2 from 6:00 pm – 7:30 p.m. and Obedience training Tuesday morning November 3 from 10a.m. – 1:00 p.m.
Crates may be set up at these times.

Crating space and exercise areas will be designated; please use the appropriate areas for each.

SSABDTC Rally Rules November 4, 2020

- No spectators will be allowed in the building
- No food will be provided
- Crating will be allowed in the building but be sure your chair is 6' away from the people around you
- Social distancing must be maintained at all times
- Face coverings will be required at all times except when you are in the ring exhibiting your dog
- We will have express check-in at the front door. You will need to drop off your COVID-19 release and pick up an envelope with your rally courses, armbands and rubber band.

DIRECTIONS TO THE SITE:

From I-80: Exit Route 30 (Maple Street) East. To Cedar Road stop light turn Left. To Francis Road turn Right. The 4H field will be on your left.

From I-355: Exit on Route 6. Go East on Route 6, to Cedar stoplight turn Right. To Francis Road turn Left. The 4H field will be on your left.

From Route 50 or 45: Go to Laraway Road or Route 30. Turn West to Schoolhouse Road, turn Right. (just West of Wolf Road - Stop Sign if coming off of Laraway, Stop Light if coming off of Route 30); Deadend on Francis Road - turn Left. The 4H field will be on your right about a mile down.
