Postdated and returned checks do not constitute a valid entry fee. The test-giving Club will add a collection fee to the amount of each returned check (\$30). Subsequent returned checks from the same exhibitor may result in their being put on a cash only basis.

Refunds for bitches in season will be refunded less \$3.50 per run, if requests are submitted to the Field Secretary at least 30 minutes prior to the start of judging for the day and are accompanied by a veterinarian certification.

How are Fast CAT Points and Titles Awarded?

- The dog's time to complete the 100 yard dash is converted into MPS. ⊋ (2)
- A handicap system is applied to a dog's MPS to determine the number of points earned. The handicap system is based on the height of the dog at its withers.
 - 18 inches or greater = handicap of 1.0
- 12 inches to less than 18 inches = handicap of 1.5
- Below 12 inches = handicap of 2.0
- Points = MPS multiplied by the dog's handicap €4
- Fast CAT titles are suffix titles earned at designatedmilestones. BCAT = 150 points
