BEST OF BREED COMPETITION

The following categories of dogs may be entered in this competition: Dogs that are Champions of Record and dogs, which according to their owners' records, have completed the requirements for a championship but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed Competition is limited to a period of 90 days from the date of show where the dog completed the requirements for a championship.

Awards of Merit. At the discretion of the judge, up to four (4) Awards of Merit to be awarded to dogs or bitches competing in Best of Breed. Those selected as Best of Breed, Best of Opposite Sex, or Select Dog or Bitch are not eligible. Winners Dog & Bitch, Veteran Dog & Bitch, Hunting Retriever Dog & Bitch, and Working Retriever Dog & Bitch are eligible for Award of Merit.

Reserve Three Point Major. Reserve Winners Dog and Reserve Winners Bitch will be awarded a three-point major, provided the criteria set forth in Chapter 16, Section 1 of the Rules Applying to Dog Shows is met.

Following Best of Breed Judging there will be competition for: Best Puppy in Puppy Classes, Best Bred By Exhibitor from Bred By Classes, Best Veteran from Veteran Classes, Best Field Dog from the Hunting Retriever Classes and Working Retriever Classes.

Best Puppy in Regular Puppy Classes: The First Place Winners from the 6-9 mos, 9-12 mos, and Bred by Puppy classes will compete for Best Puppy In Regular Classes.

Best Bred by Exhibitor. The First Place Winners from the Bred by Puppy and Bred by Adult classes will compete for Best Bred By Exhibitor in Show. Winner of BBE in Show will receive one free litter registration offered by AKC

4 – 6 MONTH BEGINNER PUPPY COMPETITION

One combined class will be offered for Tollers that are four months of age and over but under six months on the day of the competition. For further 4-6 Mo Beginner Puppy Competition Regulations, see www.AKC.org. See additional information about the Pee Wee Class Special Attraction on Page 20.

Chapter 11, Section 8 of the "Rules Applying to Dog Shows" provides that "Neutered dogs and spayed bitches would be allowed to compete in Brace, Team, Veterans and/or any other single entry non-regular classes only at independent specialties and/or those all-breed shows which do not offer any competitive classes beyond Best of Breed."

Hunting Retriever Class: Class for dogs and bitches (may be altered) that have a Working Certificate Excellent (WCX) from the NSDTRC (USA) or an AKC Senior Hunter title (SH), Master Hunter title (MH) or Master Hunter Upland title (MHU).

Working Retriever Class: Class for dogs and bitches (may be altered) that have a Working Certificate (WC), Working Certificate Intermediate (WCI) from the NSDTRC (USA), AKC Junior Hunter Title (JH), Junior Hunter Upland Title (JHU) or Senior Hunter Upland Title (SHU).

NON-REGULAR CLASSES INVOLVING MULTIPLE DOG ENTRIES

As the judge's decision in the following classes are based on the merits of more than one dog or bitch, no one of the dogs or bitches judged first in these classes will be eligible to compete for Best of Breed by virtue of having won in these classes. Stud Dog & Brood Bitch class entrants at an independent specialty may be altered.

STUD DOG: Class for Stud Dogs and no less than two of their Get. Stud Dogs must be entered in the Stud Dog Class and must be shown in the ring with their Get. Owner of Stud Dog need not necessarily be the owner of the Get. Entry only to be judged based on the merits of the Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or the Standard for its breed. Get MUST be entered in one of the Regular Classes or Best of Breed Competition. Notation must be made on entry form.

BROOD BITCH: Same as for Stud Dog except substitute Brood Bitch for Stud Dog & Produce for Get.

SWEEPSTAKES COMPETITION

Eligibility: This Sweepstakes is open to all Nova Scotia Duck Tolling Retrievers, who, on the day of the show, will be at least six months and under eighteen months of age. Classes to be divided by sex and age. Sweepstake Classes will be judged prior to the regular breed classes. PROFESSIONAL handlers are not eligible to complete in sweepstakes at NSDTRC (USA) events unless they are an owner, co-owner and/or breeder of record of the dog(s) being handled. Champions of record are allowed to enter. Indicate "Sweepstakes & Age Division" in the Additional Classes space.

Neutered males and spayed bitches are eligible for Veteran Sweepstakes. PROFESSIONAL handlers are not eligible to complete in sweepstakes at NSDTRC (USA) events unless they are an owner, co-owner and/or breeder of record of the dog(s) being handled. Champions of record are allowed to enter. Altered dogs and bitches may be entered in Veteran Sweepstakes. A dog **NEED NOT** be entered in the Regular Classes at this show. Indicate "Sweepstakes & Age Division" in the Additional Classes space.

ALL SWEEPSTAKES MONEY PRIZES

Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class by notifying the Superintendent or Show Secretary prior to the judging of the class at the show.

OPEN CLASS: This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

MASTER CLASS: This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won the 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to complete for the following year. **NOVICE AND OPEN CLASSES DIVIDED:**

- Junior 9 years old and under 12 years old on the day of the show
- Intermediate 12 years old and under 15 years old on the day of the show
- Senior 15 years old and under 18 years old on the day of the show

BEST JUNIOR HANDLER: Winners from each class will compete for Best Junior Handler.

NOTICE: Junior Handers must include their AKC JUNIOR HANDLER NUMBER on each entry. You may obtain your junior identification number by calling the AKC, Judges Education Department, (919) 233-9767. BE SURE ALL INFORMATION for Junior Showmanship Classes is entered on front and back of entry form.

NOTE: SUBSTITUTION OF DOG IN JUNIOR SHOWMANSHIP AT THE SHOW(S). There will be an Administration Fee of \$5.00 charged for any substitution of dog in Junior Showmanship at each show. In addition, if the dog originally entered in Junior Showmanship was an additional entry, and the dog being substituted is not other wise entered in the show, the Junior Showmanship Only fee applies.

AKC National Owner-Handled Series



(Remember to check the box at the bottom of the entry form) The AKC National Owner-Handled Series is a non-titling competition for

dogs that are exhibited by their owners that are not professional handlers. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry using the check box on the entry form. Eligible dogs will be identified by an asterisk in the judge's book and the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers, household members and current assistants** to professional handlers may not exhibit the dog in this competition.

Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch, and undefeated winners of the non-regular classes. This excludes all dogs defeated during class and winners competition for the regular show.

* Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years.

** A current assistant is defined as anyone employed by a professional handler on a fulltime basis, or, assisting a professional handler at the show or any show during the cluster/weekend.

CHALLENGE TROPHIES

BEST PUPPY CHALLENGE TROPHY:

Traveling Trophy is to be engraved with the winner's name and returned to the club each year until retired. The trophy is a two-tiered wood base of natural-color cherry wood. A crystal block with a 3dimensional image of a Toller adorns the top of the trophy. The crystal block is illuminated from within the trophy with lighting. This trophy is offered by Jamie Como and Kathy Kosbensky Como for the Best Puppy At a NSDTRC (USA) National Specialty, after they have on Best Puppy three times at previous National Specialties to become permanent owners of the Sagewood Kennel Best Puppy Challenge Trophy. This trophy is offered on a three-time win basis, and possession of the trophy will be awarded permanently to any owner who wins the trophy three times at three different National Specialty Shows, not necessarily with the same dog.

BEST VETERAN CHALLENGE TROPHY:

Traveling Trophy is to be engraved with the winner's name and returned to the club each year until retired. This trophy is an etched image of a Toller coming out of the water with a retrieved duck. This trophy is offered in memory of Robert Hugh by Dee Nichols (KD's Kennels) and Laura White (Cinnstar Retrievers) for the Best Veteran at the NSDTRC (USA) National Specialty. This trophy is offered on a three-time win basis, and possession of the trophy will be awarded permanently to any owner who wins the trophy three times at three different National Specialty Shows, not necessarily with the same dog.

HIGH IN TRIAL CHALLENGE TROPHY:

Traveling Trophy is to be engraved with the winner's name and returned to the club each year until retired. This trophy is a silver cup on a wooden base. This High In Trial trophy is offered by Lonetree Kennels through the NSDTRC (USA). This trophy is offered on a three-time win basis, and possession of the trophy will be awarded permanently to any owner who wins the trophy three times at three different National Specialty Shows, not necessarily with the same dog.

Perpetual Trophies

STRUAN AWARD: Traveling Trophy with engraved duck bands and keeper duck bans to be awarded each year, engraved with the winner's name and returned to the club each year. This is a perpetual trophy to be awarded at the Toller Field Test Rosette Ceremony, Eric Johnson, founding member. This is a perpetual trophy to be awarded to the NSDTRC (USA) member-handler of the oldest dog of either sex to earn a Working Certificate Intermediate at a NSDTRC (USA) Hunt Test. To be eligible for the award, a dog must be five (5) years old or older on the day of the test and not have earned a title in any field-testing program at a level that involves a double marked retrieve. If no dog wins this at the National, then records has to run a report of all dogs over the year that qualified for a WCI in the club year by age.

PARKLAKE AWARD: Traveling Trophy. Engraved Plaque to be engraved with winner's name and returned to the club each year. Specialty Show Chair— Awarded in the ring each year. The Parklake Award is a perpetual trophy (Award) to honor the breeder(s) of the Best Stud Dog at each NSDTRC (USA) National Specialty. It is named in recognition of Parklake Kennels, and Jack and Peggy Park, and their contributions to our breed.

WINDY AWARD: Traveling Trophy, Hand Carved Red Stone Trophy, to be engraved with winner's name and returned to the club each year. The Windy Award is an award to recognize the High In Trial Master agility dog at each annual National Specialty. Nancy Tucker is the sponsor of this award in honor and memory of her beloved Windy, MACH HR Cinnstar's Windy Taramac CD, JH, MXB, MJS, NAP, OJP, RE, CGC, WCI, VCS, CDX-C, JS-3, RS-3, W-FD, DD-SJ, UAD, SJI, USJ, SD (October 13, 2003 - October 17, 2013). Eligible Tollers for this award will come from the entry list of all dogs entered in both regular Standard and Jumpers with Weaves at the Masters level at each National Specialty. The award will be calculated first based on score and then on fastest yards per second.

CODE OF ETHICS Nova Scotia Duck Tolling Retriever Club (USA) Approved 1996 - Updated 2023

- I subscribe to the purpose of the NSDTRC (USA) as set forth in the Bylaws and will abide by the rules set down by the Club.
- I will acquaint myself with the NSDTRC (USA) approved Breed Standard for the NSDTR (Toller), and with principles of good health and grooming for the breed.
- I will exhibit sportsmanlike conduct both spoken and written before, during and after all events and
 will encourage others to do so. I will uphold the AKC Code of Sportsmanship and will refrain from spoken
 and written public criticism and malicious degrading of people and their dogs.
- I will ensure humane treatment, including proper feeding, maintenance, health care, and training, for all
 my animals and will encourage others to do the same.
- I will commit myself to continue education in matters pertaining to the care and training of the Toller.
- If I breed, I will strive to improve the Toller breed according to the NSDTRC Breed Standard. I will
 conscientiously plan each breeding, choosing only parents of appropriate temperament, appearance,
 and other desirable qualities.
- I will become aware of genetic defects that can be harmful to the breed. When breeding, I will endeavor to select animals that will reduce the incidence of genetic problems while enhancing the positive attributes and abilities of the breed. I will be open with all persons interested in the welfare of the Toller and will discuss possible physical or temperament defects in my own stock.
- I will act responsibly in regard to all puppies produced by my breeding for the lifetime of the puppies.
- I will never knowingly sell to or place a Toller with unethical persons or those who would not provide proper and humane care to the dog. I will refuse to sell any Toller to any pet shop or to any wholesale dealer in dogs.
- Should I become aware of the mistreatment, abuse, or need for relocation of any Toller, I will make every effort to be of assistance by notifying the breeder of the dog involved and the appropriate local authorities, and I will assist in any other manner in which I am able.

- 1. Entries must reach the Show Secretary, Livetrial.net, 817 Ogden Ave #4439, Lisle, IL 60532, by the closing date & time specified in the Premium List. After which time no entries can be accepted, canceled, changed, substituted, corrected, completed or signed and no entry fees refunded. Any change or cancellation must be made in writing and received prior to closing, except as provided in Chapter 11, Section 6 of the American Kennel Club Dog Show Rules and Regulations. Saturday September 6, 2025 – NO ENTRY FEE – JUDGE: Ms. Ronda Bermke The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5–9 years of age. Safety is a primary concern. Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements as specified by the club.
- All dogs entered must have the proper lead and collar.

A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring. The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together.
